2010 Summer Day Camp CIP Program

Eatontown Recreation is offering a **Summer Counselor Intern Program** to Eatontown boys and girls who are completing grades 7 & 8 as of June 2010. A position as a CIP involves the following:

- You will be paired up with a regular counselor in our Summer Day Camp Program. The children you will be working with are in grades Pre- K – 2 or grades 3 – 6.
- This is strictly a **volunteer position**. You will not be paid any money, enrollment is limited. All applicants will be interviewed and best qualified candidates will be chosen.
- A position as a CIP with Eatontown's Summer Day Camp Program does **NOT** guarantee you a place as a regular counselor in the future.
- You must be reliable and available for **all dates and times listed below**.

7th & 8th graders → will be assigned to Wolcott Park (South Street and Rt. 35, located behind the McDonald's).

Time you will need to work is 8:30 AM – 12:30 PM.

- ◆ Parents are responsible for providing/arranging their own transportation to and from camp.
- ◆ Parents must provide CIP's with a snack and beverage daily.

This program runs Monday through Friday for six weeks. In case of inclement weather, call the Recreation Office after 8:00 AM. A voice message will be left on the answering machine regarding where camp will take place.

The program will **begin** on Tuesday, July 6, 2010 and **end** on Friday, August 13, 2010. The fee for this program is \$30. per chosen CIP. Make checks payable to "Borough of Eatontown". Free services are available to those without the ability to pay. **Registration dates: 5/3/10 - 6/4/10.
